For monographs, the editorial board appoints an editor to each book, who is usually a member of the Institute and an active researcher.

All monographs of the [Založba ZRC](#) are peer reviewed by at least two reviewers. The review process is managed by the editor and should normally be completed within six months.

ZRC SAZU actively supports open science. Authors publishing with Založba ZRC must agree to the copyright provisions and adhere to the ethical principles of publication. No Book Processing Charge is payable by authors.
